Treasurer's Report

The Treasurer's Report dated September 15, 2022 was reviewed. The current balance is \$53,823.66. Major expenses for the year include website hosting and domains, D&O insurance, marketing and awards, and webinar and meeting expenses. To date there has been \$6,513.40 in income from membership dues, and \$4,167.03 in expenses.

There is \$4,358.15 in membership money being held for GISMO, and \$776.31 for WNY.
