Welcome

Karyn Tareen introduced President Mary Susan Knauss. President Knauss welcomed the membership and thanked them for attending the NYS GIS Association Annual Meeting. President Knauss acknowledged and thanked Board Members, Committee Chairs, and Committee Members for their dedication and hard work. President Knauss also thanked the NYGeoCon Committee for an excellent conference.

Treasurer's Report

The Treasurer's Report dated September 15, 2023 was reviewed. The current balance is \$58,208.06. Major expenses for the year include website hosting and domains, D&O insurance, general liability insurance, marketing and awards, and meeting and conference expenses. To date there has been \$31,237.29 in income from membership dues and conference fees, and \$26,852.89 in expenses.

There is \$5,105.33 in membership money being held for GISMO, and \$982.79 for WNY.

A motion was made by Ana Hiraldo-Gomez to approve the Treasurer's Report. Motion was seconded by Carol Zollweg. Motion carried unanimously.

Bylaw Amendments

The changes are designed to strengthen the Board and add additional talent and focus. The Board is recommending that the size of the Board be increased to six (6) Directors. This will create two (2) new Director positions with the alternate year terms currently in place. It is also proposed that the requirement that Past-Presidents wait two (2) years before running for Director be removed. The most forward-looking change is the creation of a new position: Information Technology Officer (ITO). The back office of the Association needs rejuvenation. This appointed position will focus on achieving that goal. The bylaw amendments were approved by vote of the membership.
