Treasurer's Report: Matthew Adam, Treasurer

The Treasurer's Report dated September 16, 2025, was reviewed. The current balance is \$95,273.87, including money being held for GISMO and WNY. Major expenses for the year include website hosting and domains, D&O insurance, general liability insurance, marketing and awards, and meeting and conference expenses. There has been \$78,853.03 in income from membership dues and conference fees, and \$50,267.65 in expenses.

There is \$10,924.47 in membership money being held for GISMO, and \$1,693.55 for WNY.

A motion was made by Ana Hiraldo-Gomez to approve the Treasurer's Report. Motion was seconded by Mary Susan Knauss. Motion carried unanimously.

 - Added a second working committee focused on the Clerks
 - DOT Tech Group will be working with NYSGISA to migrate data and a webmap to the associations' AGO account

- Worked with NYSAPLS to craft language for the legislation for NYS to allow National Spatial Reference System (NSRS) as the new datum
- Worked with the NY Clearinghouse and NYDOT to successfully make information about State Highway numbers available in the clearinghouse
- Education Committee (Paula Lazrus, Chair)
 - o Committee renamed in 2025 to Educators Committee
 - o Greatest challenge is to get more academics to see the Association as an organization that speaks to them
 - Looking into ideas to get more educators involved
 - o Supporting geo mentor via GISMO
 - o Ongoing outreach project with some K-12 schools in LI
- Membership Committee (Binod Shah, Chair)
 - o Three new members joined the Membership Committee, expanding it to a total of six active members.
 - As of October 5, 2025, total membership has increased to 482.
 - A year-long membership drive was successfully conducted, with promotional flyers shared widely across social media platforms.
 - o Numerous private- and public-sector employees were personally contacted and encouraged to join and support the membership drive.
 - o Members were notified about their renewal status, and information for new memberships was distributed through LISTSERVs and social media channels.
 - The committee **recommended introducing a Life Membership option** to help retain long-term members.
 - The committee also **requested an increase in the number of webinars** to better engage GIS students and professionals.
